## Edgemont Residents are invited to participate on the School Board Nominating Committee

The Edgemont Community Council, the umbrella organization for Edgemont's civic associations, sponsors the School Board Nominating Committee ("SBNC"), providing an impartial chairperson and underwriting its costs. The School Board Nominating Committee is charged with interviewing and recommending residents for the annual election of members of the Board of Education. The committee consists of two voting members as well as up to two alternate members from each civic association and one member from the high school student body. Each voting member may serve for a term of two years. Alternates are called upon to serve in the event a voting member cannot complete a term. To qualify for membership on the SBNC a person,

- Shall be a resident of the school district for at least three years
- Shall not be the spouse of a current school board member
- Shall not be the President or Vice President of a civic association
- Shall, if the spouse of a prior member, wait until a period of one year has passed from the last date of service of such prior member
- Shall not have served a consecutive two year term within the last three years

The SBNC membership year begins on July 1 and ends on June 30. During that time all members are required to attend a minimum of three school board meetings before the start of the candidate interviews in order to be eligible to participate in the nominating process. A member must also attend all interviews in order to be eligible to vote at the Voting Meeting.

As the sponsor of the SBNC, The Edgemont Community Council encourages all residents to consider volunteering for this committee or to submit names of residents they would like to nominate for membership. All submissions should be sent to one's neighborhood civic association president or to the Edgemont Community Council by **February 16** to be considered for the coming year.
